A Pure Clay—is a soil in which very little sandy silicious matter is found; accurately it consists of a chemical combination of about sixty parts of silica and forty of alumnia, with a trace of oxide of iron.

A Strong Clay-contains about 20 parts in 108 of sand, capable of separation.

A Clay Loam-contains a large proportion of sand, easily seperated. A Loam-contains 1-2 or more
